## AGREEMENT on business and technical cooperation

### I

#### (Subject of agreement)

- (1) The Agreement on Business and Technical Cooperation (hereinafter referred to as the Agreement) of higher education institutions and non-academic institutions is a document that sets out common values, principles, principles and priorities of cooperation between a higher education institution and a non-academic institution in the field of climate-smart urban development, based on green economy and energy efficiency in the non-academic sector.

### II

#### (Definitions of terms)

- (1) A higher education institution is an institution engaged in the activity of higher education in accordance with the law.
- (2) A non-academic institution is any registered organization in the field, public and local government, and non-governmental organizations, citizens' associations, and the real sector.
- (3) The green economy is an economic model that advocates sustainable development, seeking solutions that bring economic, social and environmental benefits.

- (4) Energy efficiency is the planned implementation of measures aimed at using the minimum possible amount of energy, so that the quality of life level of production remains at the same level
- (5) Urban development is strategically planned sustainable development through the exchange of knowledge, financial resources and other urban policies and goals.

### **III**

#### **(Shared vision)**

- (1) The signatories of the Agreement express their commitment to strengthening the capacities necessary for climate-smart urban development, based on the principles of sustainability, exchange of knowledge and experience, energy efficiency and green circular economy.
- (2) In particular, the signatory parties to the Agreement reaffirm their commitment to cooperate in meeting the conditions necessary for climate- smart urban development.

### **IV**

#### **(Obligations of higher education institutions)**

- (1) The Higher Education Institution, a signatory to the Agreement, will continue its activities aimed at creating a climate, smart urban environment through;
  - a) Improvement and modernization of curricula, based on the principles of sustainable urban development through regular higher education,
  - b) Education of third parties in the field of climate smart urban development, by organizing seminars, workshops, scientific conferences and public presentations of participation in projects in the field of urban development, energy efficiency, green economy and the importance of IT technology in planning and implementation of urban development strategies,
  - c) Organizing specialist studies in the field of urban planning and development,
  - d) Organizing non-governmental clusters to provide assistance in planning sustainable development, and monitoring and auditing the execution thereof,
  - e) In the interest of the public, beneficiaries of programs, projects and donations transparently manage public and donated funds, charged equipment and develop internal control mechanisms,
  - f) Providing expert assistance to all interested parties.

## V

### (The obligations of non-academic institutions)

- (1) A non-academic institution, a signatory to the Agreement, will continue its efforts to strengthen its own capacities to participate in the processes of creating smart urban development planning through:
  - a) Timely and transparent information to the public about the interests they represent in the process of strengthening the capacity of smart urban planning,
  - b) Providing support to higher education institutions and other institutions that are making efforts to achieve climate-smart urban development,
  - c) Cooperation with the higher education institution in the process of planning and implementation of climate-smart urban development activities,
  - d) Participation in domestic, regional and international networks, contacts with domestic, regional and international organizations and institutions, and in other ways by promoting the interests of the principles of climate-smart urban development based on green economy and energy efficiency.
  - e) Enabling students to perform student and leisure internships to students of higher education institutions in their institution.

## VI

### (Finance)

- (1) The agreement is of a typical nature and does not imply any financial obligations of the signatory.
- (2) Any obligation stipulating the financial obligations of one or both parties to the Agreement shall be subject to a separate agreement.

## VII

### (Mechanism for monitoring agreements)

- (1) The implementation of the Agreement shall be monitored by organizing periodic meetings of the Parties to this Agreement, or their joint coordinating body.

## VIII

### (Interpretation of the Agreement)

- (1) The provisions of the Agreement shall be interpreted in the spirit of mutual compromise of the parties to the thrusters,
- (2) In the event that a compromise solution to the provisions of the Agreement cannot be reached, the arbitration commission of three members consisting of one member ahead of the signatories of the Agreement and one independent member from a non-academic institution.

**IX**  
**(Consortium)**

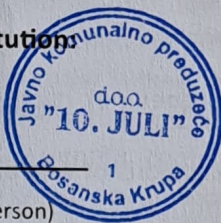
- (1) Signatories to the Agreement may consensually extend the Agreement in question with a number of higher education institutions and non-academic institutions, which accept the principles, principles and provisions of this Agreement.

**X**  
**(Transitional and final provisions)**

- (1) The agreement shall enter into force on the day of its signature.
- (2) The Parties invite institutions and organizations at all levels of government, non-governmental organizations, citizens' associations and the real sector with an interest in the field of climate-smart urban development spatial planning to promote future inter-cooperation in the spirit of the principles and principles of this Agreement.

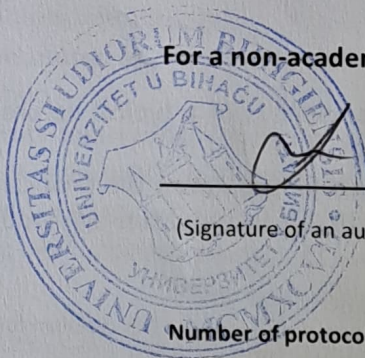
